The undersigned person/organization ("Licensee") submitting this application assumes the entire responsibility and liability for any and all damages and/or injuries of any kind or nature whatsoever, to all persons, whether employees or otherwise, and to property growing out of or resulting from the use of buildings or any other property owned by the River Vale Board of Education ("Board") and for any and all damages and/or injuries of any kind which shall occur in connection therewith. Licensee agrees to indemnify, defend and save harmless the Board, their agents, servants and employees from and against any and all losses, costs or expenses, including legal fees and disbursements, damages or injuries occurring in connection with, or resulting from the use by the Licensee, its agents, employees or participants, visitors or other persons attending the event herein, of any building or other use of the property from the aforesaid Board arising under any law whatsoever which may be in effect. The Licensee also assumes the entire responsibility and liability for damages and injuries of any kind or nature whatsoever, to all persons, whether employees or otherwise, and to property arising out of or resulting from Licensee's operation, activities, or omission of and for any and all damages and injuries of any kind

which all occur in connection therewith. The Licensee agrees to indemnify, defend and save harmless the Board, its agents, expenses, any loss or liability whatsoever arising out of or in connection with the operation, activities or omissions of the Licensee, its employees and/or officers or agents in its use of the buildings or any other property owned by the River Vale Board of Education, including, by way of example and not by way of limitation, any losses, costs, expenses, including legal fees and disbursements, damages or injuries occurring in connection with, or resulting from the use by the Licensee, its officers, agendas and/or employees of any equipment, stock, appliances, implements, tools or machinery or any other property owned, rented, borrowed by or assigned by the Board; provided, however, that the Licensee's obligation to indemnify the Board shall not apply to damage or injury resulting solely from the negligence of the Board, its employees, officers, agents and/or employees.

Unless waived in writing by the River Vale Board of Education, I agree to furnish a Certificate of Insurance specifically naming the River Vale Board of Education as an additional insured providing general liability, bodily injury and property damage coverage with minimum limits of liability not less than \$1,000,000.00 combined single limit.

Said certificate shall state that "the issuing company shall mail thirty (30) days written notice to the certificate holder named, certified mail return receipt." It shall also contain a statement acknowledging this Hold Harmless Agreement. No exceptions or limitations will be accepted.

In order to induce the River Vale Board of Education to accept this Hold Harmless Agreement, the following information concerning the intended use of the premises is furnished:
